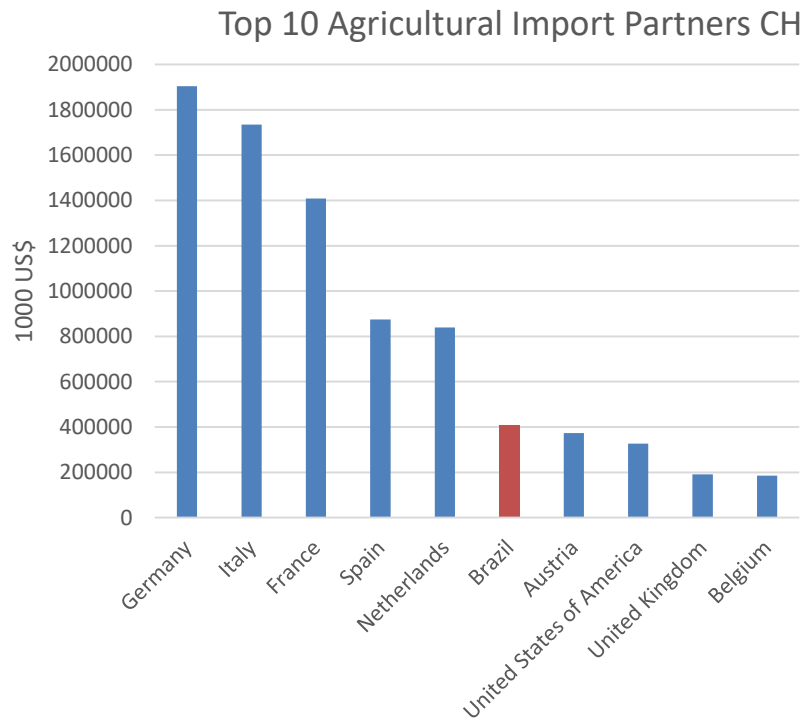

Brazil: 2006 Family Farming Law

1. Landholdings less than four fiscal modules;
2. Predominantly utilizes its own family labour;
3. Most household income originates in the family farm; and
4. The family manages the farm



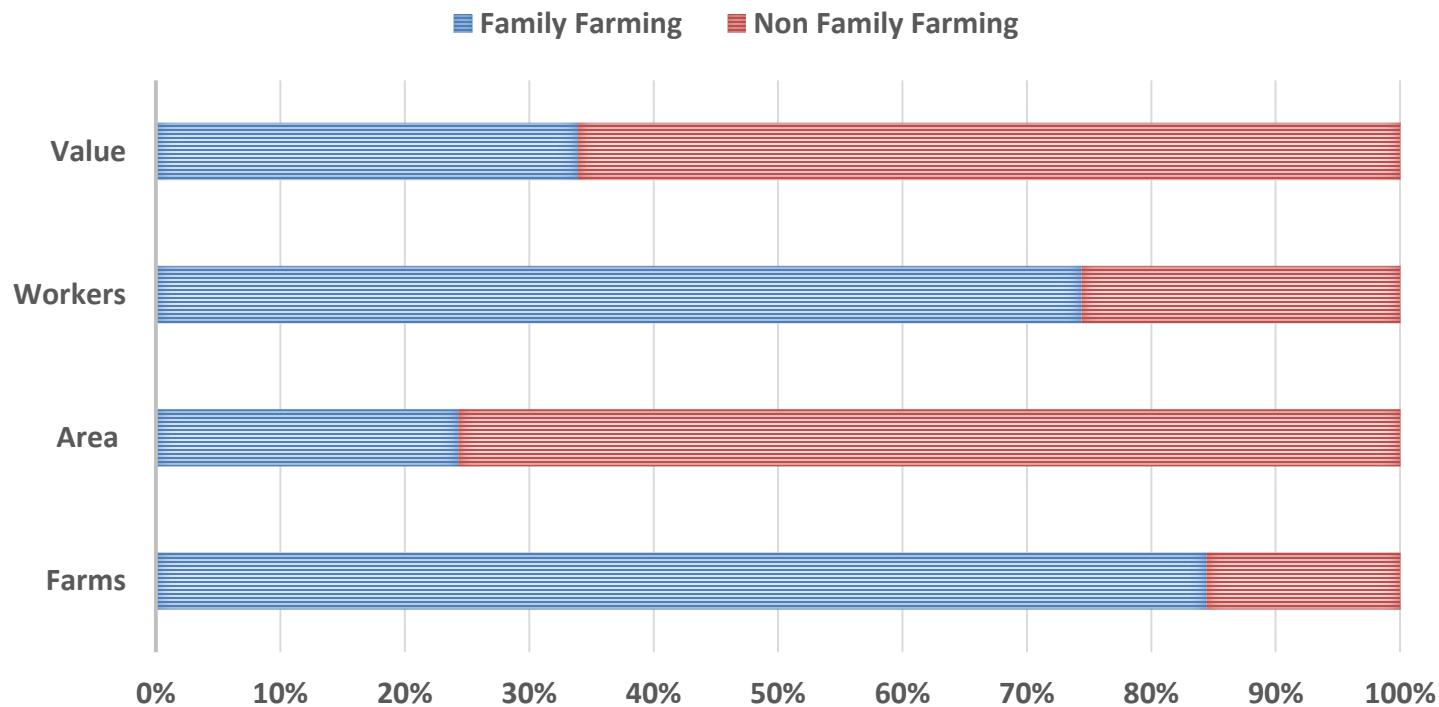

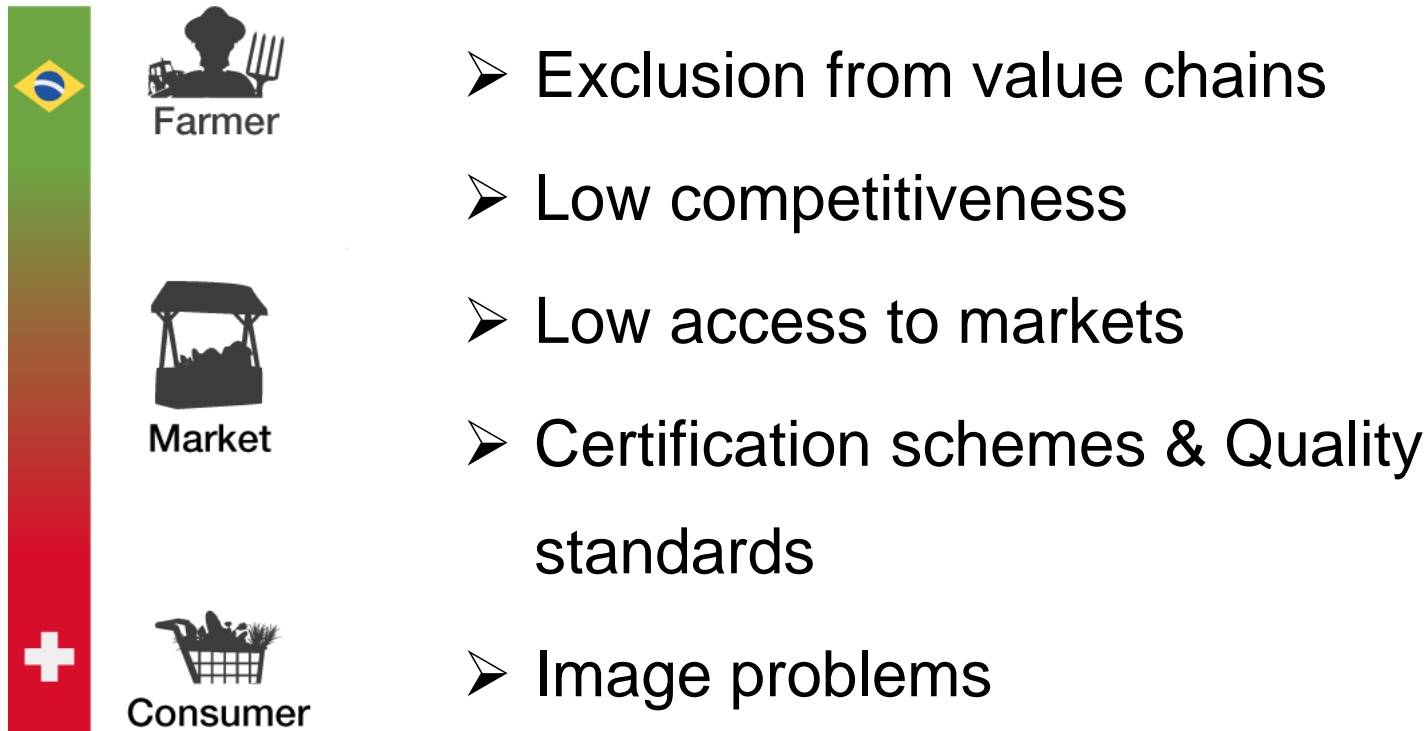

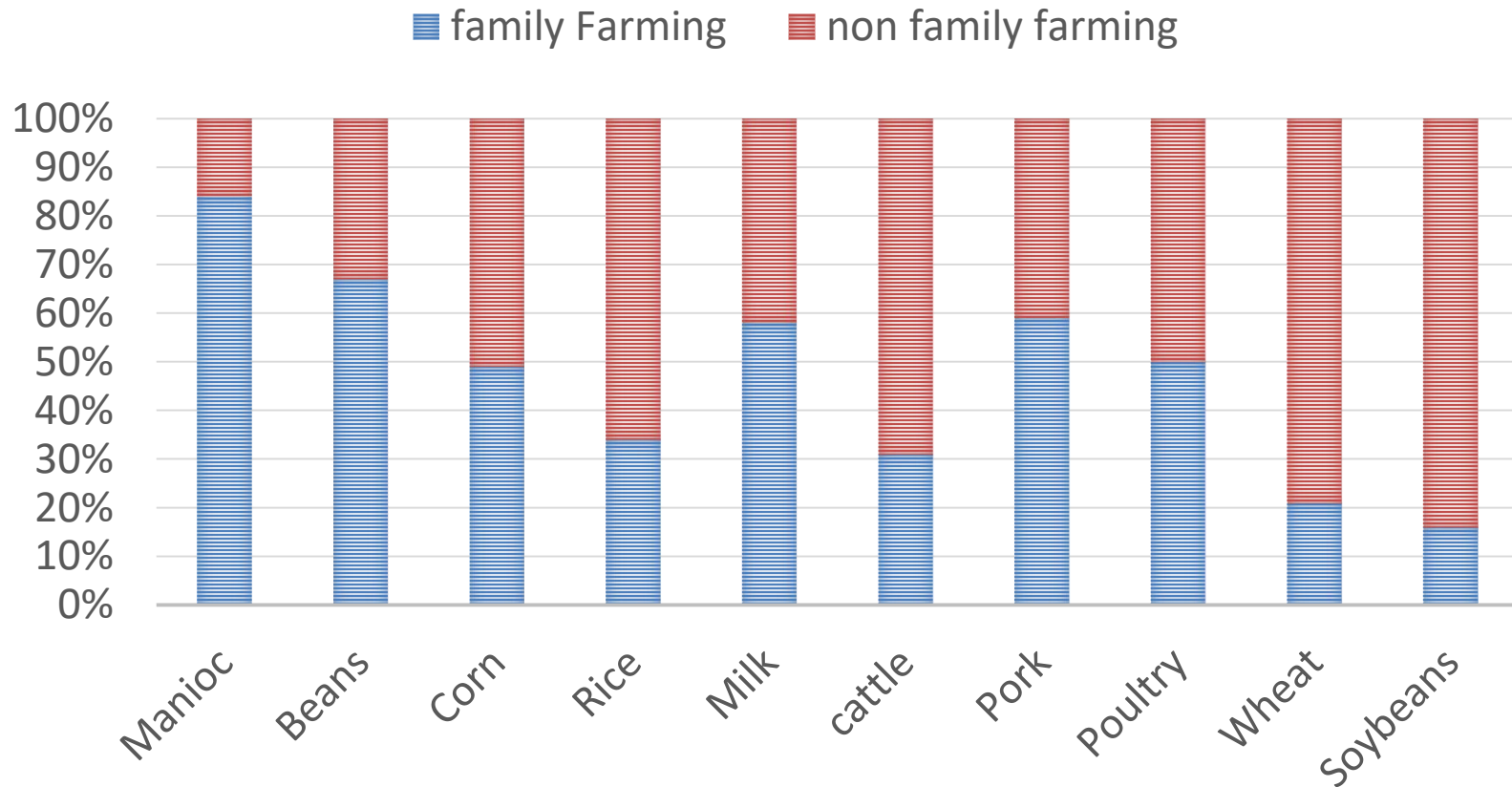

| Area range | % establishments | % total area |
|-------------------|------------------|--------------|
| Under 5 hectares | 39 | 3 |
| 5–20 hectares | 28 | 13 |
| 20–50 hectares | 16 | 21 |
| 50–100 hectares | 7 | 20 |
| Over 100 hectares | 10 | 43 |
